#### PA House Votes to Make Intergovernmental Cooperation Easier

Recently, the House unanimously passed a three bill package aimed at making it easier and less expensive to enter into intergovernmental cooperation agreements. Representative Schemel (R- Franklin) is the prime sponsor of House Bills 510 (PN 885), 511 (PN 497) and 512 (PN 498), amending Title 53 (Municipalities Generally), the Second Class Township Code and Title 11 (Cities), respectively.

House Bill 510 amends the Intergovernmental Cooperation Law giving local government entities the option of using an ordinance or a resolution when entering into an intergovernmental cooperation agreement, unless an ordinance is specifically required by law. Utilizing a resolution, rather than the currently required ordinance, will relieve municipalities of the legal advertising process and cost allowing for more efficient governance. A council of governments or consortium of local governments, separate from the organizing bodies, must still be established by local ordinance. The bill further provides that municipal authorities entering into an intergovernmental cooperation agreement may not take on any function not authorized by law or their articles of incorporation.

House Bills 511 and 512 amend the Municipal Codes referring to the process in the Intergovernmental Cooperation Law for agreements with other municipal entities.

The package of bills has been placed in the Senate Local Government Committee.
