



#### **Federal Opportunity Zones: Incentivizing Private Investment**

The 2017 Tax Cuts and Jobs Act established Opportunity Zones as a way to incentivize long-term investment in low-income communities. Private investors are offered Capital Gains Tax relief for new investment in the designated zones. Zones retain their designation for 10 years and investors can defer tax on any prior gains until December 2026 so long as the gain is reinvested in a Qualified Opportunity Fund. There are additional benefits for investors who continue to hold their investment in the Fund for at least 10 years. More than 8,760 communities in all 50 states have been designated as Opportunity Zones.

Recognizing the need for communities to have guidance in the use of Opportunity Zones, President Trump signed an Executive Order in December 2018 establishing the White House Opportunity and Revitalization Council to coordinate Federal resources. Over 160 Federal programs have been identified where preference or additional support could be granted to Opportunity Zones.




# THE LEAGUE'S LATEST (CONTINUED)

• GrantFinder email alert system — When a League member designates a license holder (user) for the GrantFinder database, the designee automatically receives an email alert each month. These emails are customized to each user when they create alerts on the GrantFinder website. Additionally, users can create as many custom alerts as they would like based on the searches they are interested in. Users can designate what day or days of the week they would like to receive the grant alert. Essentially, users can create as many, and as specific grant alert emails as they want!
