

2019 Policy Resolutions Adopted at Annual Summit

The League's Resolution Committee considered 12 policy resolutions this month at the Annual Summit. Some of the topics include: preserving local ability to regulate e-scooters; supporting repeal of the PA Separations Act; supporting the adoption of a PA Health Care Plan; supporting options for local tax collection; supporting the adoption of universal background checks prior to the purchase of firearms; and support for an extreme risk protection order law.
