## Advocacy Action

### **Become a Stronger Advocate in 2020**

With the start of 2020, the Pennsylvania General Assembly has entered the second half of the current legislative session. The League's legislative staff has tracked hundreds of bills pertinent to maintaining and supporting effective and efficient local government, but we also rely on our members to aid in our advocacy efforts.

As a local official, you are in a unique position to represent your community's needs not only locally, but also at the state level. How you might ask? **ADVOCACY**.

Whether you are writing a letter, making a phone call, or meeting with your state representative about a unique municipal issue or a League priority, you need the right

tools to communicate effectively. The recently updated League Advocacy Toolkit provides new and seasoned advocates with communication strategies, League advocacy opportunities, and legislative information so you can successfully communicate your municipality's local connection.

### **Update on the Small Cell Wireless Facilities Bill**

This week, the House Consumer Affairs Committee scheduled a voting meeting with the intention to adopt an amendment to House Bill 1400 and vote it out of Committee. The League, the PA State Association of Township Commissioners and the PA State Association of Boroughs continue to oppose the bill. Our primary reason for opposition is that local zoning control is preempted. Other stakeholders also opposed the amendment and bill; and ultimately, the Committee meeting was cancelled. **Local Public Procurement Program (L3P)** – If you have any significant purchases in mind for 2020 whether it be playground equipment, lawnmowers or a municipal vehicle, please consider taking advantage of The League’s L3P program to assist in your purchasing efforts. The L3P program simplifies using the Commonwealth’s Piggyback Purchasing program (COSTARS) by having League staff pull state contracts on a quarterly basis and sending the list to L3P subscribers. If there is a contract(s) you want to review, simply check off the contract on the listing and send it to Marcia Cavanagh; she will pull the contract and send it to you. It’s that simple! The Occupational Safety & Health Administration (OSHA) has implemented a National Emphasis Program to identify and reduce hazards which are causing, or likely to cause, serious injuries and fatalities during trenching and excavation operations. Many local government employees engage in these operations and every effort should be made to comply with these minimum safety standards.
