Headed to the Governor's Desk...

The bills below were approved by the General Assembly this week and are headed to the Governor's desk. Watch for our *Legislative Locator* next week for more legislation sent to the Governor.

[Senate Bill 940](#) would amend the Municipal Code and Ordinance Act allowing for condemnation orders to be issued against the actual property rather than the owner, while requiring all purchasers of the property to be held accountable for code compliance. The League has been supportive of this measure.

[Senate Bill 1199](#) would amend Title 75 (Vehicles) allowing for the use of personal delivery devices in Pennsylvania's communities, though it preempts most local authority. The League has repeatedly expressed concerns with the local preemption and requested an opt-out provision for communities.

[House Bill 885](#) would amend the Public Works Contractors' Bond Law requiring a prime contractor to provide 100 percent financial security for certain public works and improvement projects. The League has supported this legislation.

[House Bill 2073](#) contains the comprehensive First Class Township Code rewrite. The bill was originally introduced in November 2019 and was finally approved by the General Assembly on the last day of session. The League and PSATC have been strong advocates for this Code modernization.


