2020 Adopted Resolutions

The League is a member-driven organization relying on member municipalities to help develop policies that meet the present needs of local government. Our annual [resolutions process](#) provides every League member with the opportunity to participate in and shape The League's legislative agenda.

During The League's Municipal Leadership Summit, the voting delegates for the Resolutions Committee and Annual Business Meeting met for a final discussion and vote on the proposed 2020 Resolutions. All 14 resolutions were adopted unanimously, and the adopted resolutions will be integrated into the 2021 Policy Statement.
