### **New Year, New Legislative Session**

With the start of the new year comes the start of a new legislative session. The 2021/2022 legislative session began January 5 when members of both the House and Senate were sworn in. Currently, there are over 1,300 co-sponsor memos introduced within the first month of the new year, and as the legislative session gets rolling and more bills are introduced, it is important to remain an engaged and proactive advocate.

As a local official, you are in a unique position to represent your community's needs and ensure local government voices are heard in the General Assembly.
