Tracked  $\boldsymbol{911}$  bills in the first half of the 2021/2022 legislative session

### Finance

The League continues to utilize funds received by members to grow programs and services that will enhance the value of membership.

Trust and program fees, training contract reimbursements and dues represent the major revenue contributors. In 2021, The League was able to hold several of its events in a hybrid format causing revenues to increase slightly over 2020. Expenditures remain less than anticipated because of the continued inability to hold events in a fully in-person environment. The League has again also managed to maintain expenditures even with increases in health care, pensions, etc.

Over the last several years, the net assets of The League have continued to grow and have increased approximately 14% since 2014.
