# House Passes Expansive Unfunded Mandates for Local Government

Legislation that would place large unfunded mandates on local governments swiftly and easily passed the House on May 2 with bipartisan support.

<u>House Bill 299</u> would establish the Public Employees Occupational Safety and Health Act implementing OSHA standards for public employers. As public employers, municipalities, the Commonwealth and non-profits would all be impacted by these new standards and administrative processes.

House Bill 930 would expand permanent disfigurement benefits under the Workers' Compensation Law, allowing an employee to claim permanent disfigurement anywhere on their body, not just the head, face or neck. This legislation will increase insurance premiums, litigation and place a monetary value on all injury and surgery scarring.

The League opposes these bills, as they will result in new and expensive unfunded mandates on municipalities; and ultimately, taxpayer dollars will pay for the mandates. Both bills upend the current standards and regulations local governments have successfully been operating under for decades, straining municipalities both financially and administratively.

The League actively opposed both bills and sent letters (HB 299 <u>letter</u>, HB 930 <u>letter</u>) to the House. We will continue to oppose these bills as they move to the Senate. We encourage you to <u>reach out to your</u> <u>Senator</u> to express the detrimental fiscal impact this legislation would have on local governments.

## **Treasury Portal Remains Open For Late ARPA Report Filers**

ARPA Project and Expenditure Reports were due April 30; however, the U.S. Department of Treasury will keep its portal open for at least 60 days to accommodate late filers. Treasury strongly urges all NEUs to complete their filings as soon as possible.

Upcoming PATH Classes: Proper Planning to Prepare Successful Grant Applications (May 30 and June 28, 1-4 p.m.) - Successful grant writers develop ideas, recognize grant writing as a team effort, conduct proper research and planning efforts prior to submission, and understand the language needed for funding agencies. Learn how to plan and develop successful grant applications. Applying to local, state, federal, and foundation grants; Fiscal Management Strategies for Local Government Officials (June 7-9, 10 a.m.-12 p.m.) – Managing the fiscal affairs of a municipality is a daunting task regardless of whether you are new to the game or have been at it for years. This course was developed to provide up-to-date information and guidance that will assist elected and appointed municipal officials; Developing and Managing Your Municipal Budget (June 12-13, 9 a.m.-12 p.m.) - This virtual training course is designed to help municipal officials understand key concepts of financing, including capital budgeting, cash flow, and capitalization so that they can apply them to their community and municipal operations. Demonstrate the differences between capital expenditures and operating expenses and explain the concept of present value; Bookkeeping and Accounting Basics (June 26-27, 9 a.m.-12 p.m.) - Introduction to fund accounting using accounting basics such as assets, liabilities and fund equity. 500+ Cities Call on Congress to Stop Rail's Risky Business Endangering their Communities – In a letter to Congress led by NLC's Small Cities Council, more than 150 mayors, city council members and other

local leaders from cities, towns and villages urged Congress to pass the bipartisan S.576, the Railway Safety Act of 2023.

# National Fitness Campaign (NFC)

**Funding is now available for 2024 site partners on a first come first serve basis so we encourage those interested to apply as soon as possible.** The briefing is a 30-minute Zoom call which will qualify your community for a feasibility study and grant application.
