Federal NLC Update: ROAD to Housing Bill

The Renewing Opportunity in the American Dream (ROAD) to Housing Act of 2025 is a bipartisan housing package that bundles together at least 27 previously introduced pieces of legislation, 23 of which were introduced with bipartisan cosponsors.

The bill seeks to boost housing supply by responding to housing-related needs across multiple sectors, including state and local governments, financial institutions, and federal regulatory agencies. No single provision in the bill stands out as a solution to the housing crisis on its own. But taken together, along with housing provisions included in the recently enacted tax bill such as Low-Income Housing Tax Credits enhancements and the permanent establishment of Opportunity Zones, the bill would modernize housing policies and enhance certain programs to account for changes in today's housing market.

The ROAD to Housing Act passed the Senate in October as an amendment to the National Defense Authorization Act (NDAA). The House has also passed its own version of NDAA that does not include the housing provisions amended into the Senate bill. The House Financial Servies Committee is expected to take up the Senate's housing provisions and make further additions and possible changes, including adding new flexibilities for grantees that receive CDBG and HOME grants. Once the differences between the House and Senate are reconciled, each chamber will need to pass their NDAA bills again.

The ROAD to Housing Act received endorsements from a wide array of associations including NLC, the US Conference of Mayors, and the National Association of Counties has also been supportive, stating A section by section summary of the bill is available on the Committee's website here and a breakdown of NLC's housing priorities found in the bill can be viewed here.





Relief Opinion Letter - Combination Fire Companies — Here is a copy of the <u>Opinion Letter</u> issued by the Fire Commission to the Auditor General's office regarding relief payments that support combination departments. This letter is the result of several conversations with the DAG to reach an agreement on how to handle the rise in Combination Departments within the Commonwealth Fire Service. We agreed that items purchased with Relief Funds for a combination department can be utilized

by career personnel as long as the equipment remains the property of the Relief Association. The exception to this opinion would be personally issued PPE and training expenses for career personnel.OSFC believes that this decision will help modernize Relief practices to better align them with the realities of today's Fire Service in Pennsylvania.
