The State of the League in 2025 is one of advancement and achievement. Key accomplishments include:

- Celebrated The League's 125th Anniversary and 100th Anniversary of the Pennsylvania State Association of Township Commissioners.
- Increased League membership to 150 municipal members.
- 29 Business Leaders Network members, 2 new Business Leaders joined.
- Created Strategic Partnership and Program Manager position to focus on Business Leaders and sponsorships.
- Advocated for introduction of legislation authorizing an increase in the Local Services Tax and advocated for public notice modernization.
- Educated and informed federal officials regarding potential cuts to CDBG and other federally funded programs.
- Completed 2nd year of 2024-2026 Strategic Plan.
- Launched the League Learning Academy and the Pennsylvania Fire Credentialing Program.
- Municipal Leadership Summit featured increased attendance, outstanding keynote addresses, informative sessions and raised over \$10,000 for the Schuettler Center for Municipal Development. Sustainable Pennsylvania Community Certification



The PA Sustainable Communities Certification Program continues to expand, with:

138 Certified Sustainable PA Communities

59 are League Members

10 Platinum **54** Gold **54** Silver **20** Bronze

As part of the transition to the new Sustainable PA Certification process, the following progress has been made over the past year:

- 55 municipalities are currently in progress, including 29 League members
- 2 certifications are under review
- 2 of which are League members
- 22 municipalities have been newly certified under the updated system:
 - » 6 Gold
 - » 7 Silver
 - » 9 Bronze

In 2025, under the new criteria, League members Camp Hill Borough and Upper Chichester achieved Bronze status, Bradford Wood earned Silver, and the City of Easton and Ferguson Township attained Gold.

Public Employer Labor Relations Advisory Service

PELRAS – our labor and employment law advisory service provides training, a labor newsletter and expert legal help at discounted rates. PELRAS membership currently stands at 332 members.

GrantFinder

The League is pleased to provide members with a no-cost, value-added benefit called GrantFinder. GrantFinder, powered by Lexipol, is a real-time, online searchable database of more than 16,000 federal, state, foundation, and corporate grants available to municipalities and local non-profits.

INFORMATION & TECHNOLOGY UPGRADES

This year, our work centered on strengthening The League's technology foundation and improving operational efficiency across the organization. Significant progress was made in expanding the use of Microsoft Teams, Planner, SharePoint, and the Protech CRM, resulting in better collaboration and more streamlined workflows. We completed major Protech milestones—including the integration of Penn Prime, enhancements to Membership workflows, the addition of HubSpot for sales management, and the launch of the League Learning Academy. We also advanced several internal process improvements that have helped staff work more efficiently and ensured that our core systems better support day-to-day operations.

In addition, we modernized our communication systems by selecting and fully implementing RingCentral as our new phone platform, improving reliability, call quality, and user experience. Cybersecurity remained a top priority, with all staff completing ongoing training and phishing simulations to strengthen awareness and system protection. Looking ahead, we are preparing key infrastructure upgrades—including network and wireless improvements—and exploring new technologies identified through major industry events such as the ASAE Annual Meeting. These efforts reflect our continued commitment to building a secure, efficient, and member-focused technology environment that meets the evolving needs of The League.


Wells Fargo was presented with the **2025 Community Partnership Award** during the Municipal Leadership Summit Awards Breakfast on October 2. Congratulations

FINANCE

The League's revenues continue to increase with a 4% increase projected over 2024. The League has seen growth in its Business Leader's Network program, membership and increased registrations at its programs. This increase enables the League to continue using member-contributed funds to enhance programs and services, focusing on elevating the overall membership experience. Major revenue sources include trust and program fees, training contract reimbursements, and dues. In 2025, The League hosted several well-attended events, such as PELRAS and the Annual Summit as well as creating its own League Learning Academy. The League continues to monitor expenditures, anticipating increased health care costs and overall increases in expenses over prior year due to economic shifts and uncertainty in the market. Notably, the League's net assets have steadily grown, experiencing an approximate 17% increase since 2019.
